Update

RECOMMENDATION(S):

THAT Drainage Staff Report DSR-002/2025 respecting the North East Consolidated Drains No. 2 & 4 Engineering Report for Consideration be received; and

THAT a By-law be given two readings to provisionally adopt the North East Consolidated Drains No. 2 & 4 Engineer's Report dated November 21, 2024, prepared by Spriet Associates Engineers & Architects, under Section 4, Chapter D. 17 of the *Drainage Act, R.S.O. 1990*;

AND THAT Staff be directed to advance the North East Consolidated Drains No. 2 & 4 to that of the Court of Revision, as per Section 46(1) of the *Drainage Act, R.S.O.* 1990; and

THAT Councillor Anderson, Councillor MacLellan and Councillor Van Vliet be appointed as members to the North East Consolidated Drains No. 2 & 4 Court of Revision and Mayor Grant be appointed as an alternate member to be tentatively scheduled for March 25, 2025, at 4:00 p.m.

EXECUTIVE SUMMARY:

Initiated by a landowner request under Section 78 of the Drainage Act to improve the North East Consolidated Drain (NEC), the engineer has filed the final report with the Township.

The Meeting to Consider provides property owners with an opportunity to ask questions of the engineer or express any concerns over the Engineer's Report related to design or any gross errors. Staff are recommending the Engineer's report be adopted under provisional By-law and proceed through the Drainage Act Process.

BACKGROUND:

On August 9, 2022, through Resolution No. C-2022-146 Council appointed Spriet Associates Ltd. to prepare a Section 78 engineering report for the NEC. This appointment was in response to a request submitted by a landowner to update and improve the drain.

The site meeting with impacted property owners was held on October 13, 2022. Following survey and design work an information meeting was held September 26, 2024. The final report was filed with the Township on November 21, 2024. The Meeting to Consider provides property owners with an opportunity to ask questions of the engineer or express any concerns over the Engineer's Report related to design or any gross errors. At this meeting, Council will be given a presentation by the Engineer of Record, Brandon Widner, P. Eng., of Spriet Associates, outlining the project.

The property owners who were notified under Section 41(1) & 41(2) of the *Drainage* Act that choose to attend are to be provided an opportunity to ask questions of the Engineer or any concerns over the Engineer's Report related to design or any gross errors in the report. Should the Meeting to Consider reveal any errors in the Engineer's Report, Council may refer the report back to the Engineer for reconsideration.

However, under no circumstances is Council to refer the Report back to the Engineer regarding assessments. Concerns related to assessment are a function of the Court of Revision, with said process to occur within 60 days of the original Meeting to Consider.

Pending adoption of the provisional By-law, a Court of Revision shall be held as per Section 97 of the *Drainage Act* to address concerns with assessments. The Court of Revision shall be held on a day not earlier than twenty nor later than thirty days from the date of completing the sending of the copies of the provisional by-law to the assessed properties.

OPTIONS/DISCUSSION:

- Staff be directed to advance the North East Consolidated Drain 2 & 4 Engineer's Report to that of the Court of Revision as per Section 46(1) of the Drainage Act Drainage Act, R.S.O. 1990. (Recommended)
- 2. Do not move forward with the Engineer's Report (not recommended).

FINANCIAL CONSIDERATIONS:

Approved as part of the 2025 Capital Budget, \$79,000 was allocated to this improvement project for Township related costs. The engineer has estimated construction costs at \$481,000.

To the Mayor and Council of the Township of Wainfleet

Mayor and Council:

We are pleased to present our report on the reconstruction of the North East Consolidated Municipal Drains No. 2 & 4, serving parts of Lots 7 to 15, Concessions 4 and 5, in the Township of Wainfleet. The total watershed area contains approximately 338 hectares.

AUTHORIZATION

This report was prepared pursuant to Section 78 of the Drainage Act. Instructions were received from your Municipality with respect to a motion of Council. The work was initiated by a request signed by some of the affected landowners.

HISTORY

The North East Consolidated Drains No. 2 & 4 were originally constructed pursuant to a report submitted by R. Blake Erwin, P. Eng., dated January 11, 1971 and consisted of 4,108 lineal meters of open ditch improvements on the North East Consolidated Drain No. 2 starting at Forks Road in Lot 14, Concession 5 to Lot 9, Concession 4, and 610 lineal meters of open drain improvements on the North East Consolidated Drain No. 4 in Lot 9, Concession 4.

EXISTING DRAINAGE CONDITIONS

A site meeting was held with respect to the project and through later discussions the owners reported the following:

- the owners indicated that the drain lacked adequate depth for outletting tiles in Lot 8, Concession 4
- the Drainage Superintendent indicated that maintenance was recently completed and many of the culverts were installed at inconsistent grades
- the Road Authority for Forks Road indicated that, if the culvert is to be replaced, a concrete culvert should be considered for replacement



EXISTING DRAINAGE CONDITIONS (cont'd)

A field investigation and survey were completed. Upon reviewing our findings we note the following:

- that many of the existing laneway culverts are in poor condition and are at inconsistent elevations relative to the profile
- that the existing C.S.P. culvert under Forks Road is deteriorated and in poor condition
- that the drain lacks depth for upstream outletting tiles

Preliminary design, cost estimates, and assessments were prepared, and an informal public meeting was held on September 20, 2024, to review the findings and preliminary proposals. Further input and requests were provided by the affected owners at that time and at later dates. Based on the proposed design it was decided to proceed with the report.

DESIGN CONSIDERATIONS

The proposed design and report have been generally completed using the "GUIDE FOR ENGINEERS WORKING UNDER THE DRAINAGE ACT IN ONTARIO" OMAFRA Publication 852.

The new culverts installed under this report were designed to convey the following design storms as follows:

Forks Road 50-year storm event Overholt Road 10-year storm event Farm and Unopened Roads 2-year storm event

RECOMMENDATIONS

We are therefore recommending the following:

- that the existing Drain No. 2 be reconstructed starting at its outlet at the tributary of the Welland River in Lot 14, Concession 5 to its head in Lot 9, Concession 4, for a total length of 3,961 lineal meters
- that all the existing farm and road culverts be replaced under this report
- that any outlets that are broken or damaged are repaired as part of the construction
- that the existing Drain No. 4 be cleaned out starting at Drain No. 2, north to Forks Road, for a total length of 520 lineal meters
- that Drain No. 4, south of Drain No. 2, be officially abandoned from municipal status pursuant to Section 19 of the Drainage Act



ENVIRONMENTAL CONSIDERATIONS AND MITIGATION MEASURES

There are no significant wetlands or sensitive areas within the affected watershed area or along the route of the drains. The proposed construction of the North East Consolidated Drains No. 2 & 4 includes quarry stone outlet protection which greatly helps reduce the overland surface flows and any subsequent erosion.

We are also recommending that the following erosion and sediment control measures be included as part of our reconstruction proposal to help mitigate any potential adverse impacts of the proposed drainage works on water quality and fishery habitat:

- timing of construction is to be only at times of low or no flow
- a temporary flow check of silt fencing is to be installed for the duration of the construction at the bottom end of the ditch reconstruction
- a 3-meter-wide grassed buffer strips of existing vegetation between the top of the bank and any cultivated lands on both sides are to be incorporated as part of the drain
- some existing washouts along the course of the drain are to be backfilled and protected with quarry stone rip-rap
- quarry stone rock chutes are to be constructed at surface inlet points to reduce erosion from direct surface water access into the ditch
- some severe bends in the drain are to be protected from erosion with the installation of quarry stone rip-rap on the ditch bank as specified on the plans
- all new tile drain outlets are to be installed with quarry stone rip-rap protection
- some existing tile outlets along the course of the drain are to be repaired using an outlet pipe with a rodent gate with quarry stone rip-rap protection
- that the Department of Fisheries Letter of Advice 23-HCAA-000372, dated March 7, 2023, be adhered to and followed for the duration of the project

It is to be noted that both the existing and newly vegetated banks as well as the existing natural and newly created buffer strips along each side of the ditch are permanent parts of the North East Consolidated Drains No. 2 & 4 and shall not be disturbed or destroyed.

SUMMARY OF PROPOSED WORK

The proposed work consists of approximately 4,481 lineal meters of open ditch reconstruction including quarry stone rip-rap bank protection, rock chutes, bank seeding, and construction of farm and road culverts.



SCHEDULES

Four schedules are attached hereto and form part of this report, being Schedule 'A' - Allowances, Schedule 'B' - Cost Estimate, Schedule 'C' - Assessment for Construction, and Schedule 'D' - Assessment for Maintenance.

Schedule 'A' - Allowances. In accordance with Sections 29 and 30 of the Drainage Act, allowances are provided for right-of-way and damages to lands and crops along the route of the drain as defined below.

Schedule 'B' - Cost Estimate. This schedule provides for a detailed cost estimate of the proposed work which is in the amount of \$625,000.00. This estimate includes engineering and administrative costs associated with this project.

Schedule 'C' - Assessment for Construction. This schedule outlines the distribution of the total estimated cost of construction over the roads and lands which are involved.

Schedule 'D' - Assessment for Maintenance. In accordance with Section 38 of the Drainage Act, this schedule outlines the distribution of future repair and/or maintenance costs for portions of, or the entire drainage works.

Drawing No.'s 1 and 2, Job No. 222229, and specifications form part of this report. They show and describe in detail the location and extent of the work to be done and the lands which are affected.

ALLOWANCES

DAMAGES: Section 30 of the Drainage Act provides for the compensation to landowners along the drain for damages to lands and crops caused by the construction of the drain. The amount granted is based on \$4,647.00/ha. for open ditch work with excavated material levelled adjacent to the drain. This base rate is multiplied by the hectares derived from the working widths shown on the plans and the applicable lengths.

RIGHT-OF-WAY Section 29 of the Drainage Act provides for an allowance to the owners whose land must be used for the construction, repair, or future maintenance of a drainage works.

For open ditches, the allowance provides for the loss of land due to the construction provided for in the report. The amounts granted are based on the value of the land, and the rate used was \$45,000.00/ha. When any buffer strip is incorporated and/or created, the allowance granted is for any land beyond a 1.8-meter width deemed to have always been part of the drain. For existing open ditches, the right-of-way to provide for the right to enter and restrictions imposed on those lands, is deemed to have already been granted.

ASSESSMENT DEFINITIONS

In accordance with the Drainage Act, lands that make use of a drainage works are liable for assessment for part of the cost of constructing and maintaining the system. These liabilities are known as benefit, outlet liability and special benefit liability as set out under Sections 22, 23, 24 and 26 of the Act.



ASSESSMENT DEFINITIONS (cont'd)

BENEFIT as defined in the Drainage Act means the advantages to any lands, roads, buildings or other structures from the construction, improvement, repair, or maintenance of a drainage works such as will result in a higher market value, increased crop production, improved appearance, better control of surface or sub-surface water, or any other advantages relating to the betterment of lands, roads, buildings, or other structures.

OUTLET liability is assessed to lands or roads that may make use of a drainage works as an outlet either directly or indirectly through the medium of any other drainage works or of a swale, ravine, creek, or watercourse.

In addition, a Public Utility or Road Authority shall be assessed for and pay all the increased cost to a drainage works due to the construction and operation of the Public Utility or Road Authority. This may be shown as either benefit or special assessment.

ASSESSMENT

A modified "Todgham Method" was used to calculate the assessments shown on Schedule 'C'- Assessment for Construction. This entailed breaking down the costs of the drain into sections along its route. Special Assessments were then extracted from each section.

The remainder is then separated into Benefit and Outlet costs. The Benefit cost is distributed to those properties receiving benefit as defined under "Assessment Definitions", with such properties usually being located along or close to the route of the drain. The Outlet Costs are distributed to all properties within the watershed area of that section on an adjusted basis. The areas are adjusted for location along that section, and relative run-off rates. Due to their different relative run-off rates forested lands have been assessed for outlet at lower rates than cleared lands. Also, roads and residential properties have been assessed for outlet at higher rates than cleared farmlands.

The actual cost of the work involving this report, with the exception of Special Assessments, is to be assessed on a pro-rata basis against the lands and roads liable for assessment for benefit, outlet, and for special assessments as shown in detail below and on Schedule 'C' - Assessment for Construction. The Special Assessments shall be levied as noted in the Section "Special Assessment".

SPECIAL ASSESSMENT

In accordance with Section 26 of the Drainage Act, a Special Assessment has been made against the Region of Niagara being the increased cost to the drainage work for installing a new pre-cast concrete culvert across their road allowance on Drain No. 2, due to the construction and operation of Forks Road. The Special Assessment shall be made up of the actual cost of this work and both the final and estimated values of the Special Assessment are to be calculated as follows:

SPECIAL ASSESSMENT (cont'd)

The above special assessments shall not apply for future maintenance purposes.

If Niagara Region elects to perform the work themselves the above Special Assessment shall be reduced by \$234,100.00. Otherwise, this portion of the work shall be included in the general contract.

In accordance with Section 26 of the Drainage Act, Special Assessments have been made against the Township of Wainfleet being the increased cost to the drainage work for installing C.S.P. culverts across their road allowance on Drain No. 2, due to the construction and operation of their roads. The Special Assessment shall be made up of the actual cost of this work and both the final and estimated values of the Special Assessment are to be calculated as follows:

The above special assessments shall not apply for future maintenance purposes.

If the Township of Wainfleet elects to perform the work themselves the above Special Assessment shall be reduced by \$55,900.00. Otherwise, this portion of the work shall be included in the general contract.

In accordance with Section 26 of the Drainage Act, a Special Assessment has been made against Enbridge Gas for the cost of locating and determining the location of their gasmain on the North East Consolidated Drain No. 2 at Forks Road, being the increased cost to the drainage works. The Special Assessment shall be as shown on Schedule 'C' and shall **not** apply when prorating future maintenance costs.

In accordance with Section 26 of the Drainage Act, a Special Assessment has been made against the Niagara Regional Broadband Network for the cost of locating and determining the location of their fibre optic cable on the North East Consolidated Drain No. 2 at Forks Road, being the increased cost to the drainage works. The Special Assessment shall be as shown on Schedule 'C' and shall **not** apply when pro-rating future maintenance costs.

In accordance with Section 26 of the Drainage Act, a Special Assessment has been made against Bell Canada for the cost of locating and determining the location of their telephone cables on the North East Consolidated Drain No. 2 at Forks Road, being the increased cost to the drainage works. The Special Assessment shall be as shown on Schedule 'C' and shall **not** apply when prorating future maintenance costs.



SPECIAL ASSESSMENT (cont'd)

If any additional work is required to the drainage works due to the existence of buried utilities such as gas pipelines, communications cables, etc. or if any of the utilities require relocation or repair then the extra costs incurred shall be borne by the utility involved in accordance with the provisions of Section 26 of the Drainage Act.

GRANTS

In accordance with the provisions of Section 85 of the Drainage Act, a grant **may** be available for assessments against privately owned parcels of land which are used for agricultural purposes and eligible for the Farm Property Class Tax rate. Section 88 of the Drainage Act directs the Municipality to make application for this grant upon certification of completion of this drain. The Municipality will then deduct the grant from the assessments prior to collecting the final assessments.

MAINTENANCE

Upon completion of construction all owners are hereby made aware of Sections 80 and 82 of the Drainage Act which forbid the obstruction of or damage or injury to a municipal drain.

After completion the North East Consolidates Drains No. 2 and 4 shall be maintained by the Township of Wainfleet at the expense of all upstream lands and roads assessed in Schedule 'D' - Assessment for Maintenance, and in the same relative proportions, until such time as the assessment is changed under the Drainage Act.

Special Assessments shall **not** be pro-rated for future maintenance purposes.

Repairs or improvements to any road culvert or bridge or sub-surface road crossing required by the performance of this work and for future repair and/or replacement, shall be the responsibility of the applicable Road Authority, entirely at their cost.

After completion, the new access and farm culverts constructed under this report shall be maintained by the respective municipality at the expense of all upstream lands and roads assessed in the following manner: maintenance repair or replacement costs shall be levied 50% to the affected owner and the remainder shall be pro-rated over the upstream outlet assessments.





SUBJECT: Correspondence Request for Green Road North

RECOMMENDATION(S):

TO:

THAT Public Works Staff Report PWSR 005/2025 respecting the Correspondence Request for Green Road North be received; and

THAT Council does not entertain the upgrade of Green Road North at this time, as it does not meet the criteria in the Township's roads needs study for prioritizing future road rehabilitation.

EXECUTIVE SUMMARY:

During the regularly scheduled council meeting held on February 4, 2025, Council received a correspondence request to have Green Road North Paved.

Staff have inspected the road and, at Council's request, have prepared options to consider an upgrade of the road from gravel surface to pavement structured surface.

BACKGROUND:

Initially, Council and members of staff received an email from a local resident (on January 13, 2025) requesting the Township to pave Green Road North. Staff prepared a response and shared it with the resident and members of Council. Subsequently, the correspondence was placed on the agenda for the February 4, 2025, regular Council meeting. Council chose to direct the Manager of Operations to prepare a report for their consideration outlining the cost of fulfilling this request.

As Council is aware, the Township initiated a Road Needs Study (2023) to assess the current and future requirements of the entire municipal road network. This study was conducted by a qualified engineering firm, which evaluated road surfaces, traffic volumes, maintenance classifications, and overall asset conditions. Based on the collected data, a comprehensive road network assessment was developed. This Road Needs Study is utilized to prioritize our road improvements and also align with the Township's asset management system for future budgets. Green Road North was not identified as a priority for immediate improvements or an upgrade to an asphalt surface, as it was deemed to be in adequate condition at the time of the study. Additionally, the Township Council has approved the road network improvement plans for this year, and Green Road North is not currently scheduled for upgrades in 2025. Altering the utilization of the Road Needs Study will also necessarily alter the asset management plan and influence future budget

considerations. Staff caution that arbitrary deviation from the Road Needs Study may result in an unintended precedent for future requests to Council and staff, for additional roads to be upgraded for other establishments in the Township.

As requested by Council, staff reviewed Green Road North to examine and determine the potential costs to upgrade the road from gravel to a paved surface. Staff considered all aspects related to determine the appropriate surface for the pavement design, including drainage, culverts, road width, road base, and the type of vehicle traffic utilizing the road.

At the time of the inspection, staff could not fully review the drainage due to snow-filled ditches, but did find several required improvements to accommodate the proposed transition to a paved surface. The current road is 6 meters wide for a portion of the road from Regional Road 27 south to the first Business and narrows to approximately 4.5 meters for the remainder. Accordingly, it will require the widening of a portion of the road (approximately 110 meters) to a proper width for truck traffic, at least in the areas servicing the second commercial business, while the remainder may be left for residential access only.

Preliminary estimates including engineering, surveying, widening and finishing of the surface to a double layer of asphalt for the entire road is approximately \$270,000. An alternative to Hot Mix Asphalt, outlined above, may include the use of Cold Recycled Asphalt with a single surface treatment that will not be as strong and will need additional maintenance as compared to Hot Mix Asphalt, but has a lower initial cost at approximately \$177,000.

OPTIONS/DISCUSSION:

- 1. Council may consider the additional work that was not budgeted for during the 2025 budget deliberations.
- 2. Council consider the inclusion of this road upgrade in a future budget.
- 3. Council may choose an alternate means of funding this project to satisfy the request.
- 4. Staff would not recommend Cold Recycled Asphalt for the portion of the road required for commercial business use, but may be considered for the residential portion to find some savings. This has not been calculated at this time as it does create a transition, and due to weather-related events, staff were unable to view the site completely.
- 5. Council does not upgrade Green Road North and continues to rely on the Road Needs Study for prioritizing future road rehabilitation. (recommended)
- 6. Council may choose to allow the resident to upgrade the road at their own expense. This option would necessitate entering into an agreement with the Business owner.

FINANCIAL CONSIDERATIONS:

This project has not been budgeted for in the 2025 capital budget, and depending on the choice and extent of the scope of work, funds will need to be allocated.

If upgraded to Asphalt road surface, future costs for maintenance, repairs and eventual replacement will have to be accounted for in future budgets.
