RE: No Parking signs removal Erie st and Brawn rd that I am requesting to be replaced

Please note at one time there were NO PARKING SIGNS on both sides of Erie and Brawn, according to Mark, town council in 2018 asked to have some of the NO Parking signs removed, which now are the ones I am now requesting to be replaced. The purpose of those signs served a greater purpose. One reason was to control the crowd at the beach. Of all times, now is the time where we need to control the crowd at beach.

Erie St which runs along side of 905 Rental is a lane way at the best (not a road and not a street) . It is one and half cars wide, for two cars to go down it each must drive on the grass on each side of the laneway to get pass each other. There is no gravel shoulder on either side.

When the NO parking signs went up on Erie st , there were three reasons .

- How wide the road is (it is not two car wide)
- We had to have an ambulance get to one of the homeowners on Gallinger St and there were cars parked on both sides of Erie st. Ambulance had to go around instead of the direct route. There was a car coming down Erie st when Ambulance was coming to turn on Erie. Even having one sided parking causes issues if two cars are coming from opposite directions. It's impossible for them to pass if one is a larger pick up truck like what we own.
- Parking caused a huge issue as they parked all the way to Lakeshore and if you were leaving Erie st. you could not see what traffic was coming up from Lakeshore.

On top of all the garbage and what not they left behind or sneaking up on the empty lots to do their bodily functions.

The removal of the one side of Erie St No parking signs is bringing back all the same issues .

Asking for both sides of Erie street to be posted NO PARKING .

I would also like for you to consider putting the temporary speed bumps on Gallinger st and Erie st. We have just on our little street (Gallinger st) 3 homes with 7 children under 7 years old and will be having a new home built on the road in the near future with one more very young child. The traffic on Gallinger and Erie this summer has been crazy. My small community of families are fearful for their children. We have had cars jump the road and land in my field or the Cowals front lawn in the last couple of months.

When the No Parking signs went up in the area, Brawn Road was No Parking on both sides. One side of the road the signs have been removed. Cars were parked past the Gord Harry Trail this past weekend.

When a few of us went around to the paid parking and all the roads where people were parking we noticed one thing in common. There were approx. 182 vehicles with Toronto and area dealer stickers or the surrounds for the license plates. Some were telling us that Long Beach is where they are being sent after being turned away from Fort Erie, St Catharines, Port Colborne and Crystal Beach. Is anyone seeing an issue here? We were also told it there is a web sites for Toronto people telling them where Long Beach is, how lovely our beach is and where to park. What locals we used to see at the beach are telling us they will not come to the beach due to the overcrowding. I have lived in my home for 31 years and I have never seen a crowd that goes from the beach entrance all the way to Long Beach resort . At most on any given day in the past summers, the crowd would only go about 5 cottages past the beach entrance and that would be Fleeters, Dunnville and Port people.

Do we have any idea when the region is going open up the old Lake wood Camp? That would take a lot of pressure off of Long Beach.

I am also asking and never in my dreams did I think I would be interfering with local business.

905 Rentals has parking which I understand for their customers and beach parking. MY issue is they can not and do not have any control of their parking when they are at the beach doing their business. By not having control of their parking, cars park on the property or should I say they park on the shoulder of the road and park riding the white line of the road. I truly mean if you matched up the door handle on the car it would perfectly align with the white line of the road. This again is causing an issue if you are trying to get off Erie st. on to Lakeshore or for that fact driving down lakeshore or even trying to cross the road. I would like to see Bylaw hand out tickets for this and maybe towing. It is an accident waiting to happen I also would like to see any parking they have behind their property fence fined and towed. (these cars are parked on Gallinger rd shoulder where there is no parking on either side .

I would be very interested to hear from you to see if we can come to some agreement with regards to my letter .

Re: COVID-19 Funding

Oshawa City Council considered the above matter at its meeting of June 22, 2020 and adopted the following recommendation:

“Whereas on March 11, 2020, the World Health Organization and the Canadian Government declared COVID-19 a global pandemic; and,

Whereas on March 12, Ontario ordered schools closed and by March 17, began a more extensive shut down; and,

Whereas the pandemic has led to the closure of public spaces and the cancellation of events around the world throughout the country our province and right here within our own community, causing great stress on the arts sector; and,

Whereas local cultural organizations such as the Oshawa Folk Arts Council representing over 13 member clubs and organizations, as well as the many local service groups such as the Oshawa Rotary Club, have all been forced to cancel major events (i.e. Fiesta Week; Rib Fest; etc.) which historically contribute in large part to the fundraising and operational financing efforts of these sociocultural entities; and,

Whereas the Government of Canada and the Province of Ontario have committed they through the Canada Council for the Arts will continue to work with the Government of Canada, as well as provincial, territorial, and municipal partners, to ensure the strength of the sector; and,

Whereas at present, the Canada Council's for the arts priorities as are our collective governing priorities are to ensure the health and safety of people across Canada and around the world and to work towards the sustainability and recoverability of the arts sector; and,

Whereas a significant period has past without further indication as to what tools, funding measures, or financial support our local social cultural, service clubs, and children/youth minor sporting originations can readily access to help support their operating costs and programming,

Therefore be it resolved:

1. That the Federal, Provincial, and Regional Government help local municipalities assist their local social cultural, service clubs, and children/youth minor sporting originations with clear and definitive relief funding programs directed to help sustain the afore mention groups through these trying times inflected on them by the affects of COVID-19; and,
2. That a copy of this resolution be sent to the Prime Minister of Canada, the Premier of Ontario, all Ontario Municipalities, all Members of Provincial Parliament, all Members of Parliament and Association of Municipalities of Ontario and Federation of Canadian Municipalities."
